COMPETITION RULES

COMPETITION RULES ARE IN LINE WITH THE NATIONAL PLAYING FORMATS AND FFA RULES FOR MINIROOS:

1. Teams will consist of a maximum of 13 players. The 13 players on each team are all to be registered with FFA through the nominated team.
2. No more than NINE players are to be on the field of play during the course of the game.
3. Technical areas are provided for the teams. **ONLY THE TEAM COACH, MANAGER AND UP TO FOUR INTERCHANGE PLAYERS ARE PERMITTED IN THIS AREA.**
4. Duration of the games will consist of two 15-minute halves, with a half time break of 5 minutes.
5. All teams must have their Team cards handed into the competition officials 15 minutes prior to their 1st Game of the day.
6. Time keeping will be under the control of the **OFFICIAL TIME KEEPER.**
7. A siren will signal a 1-Minute warning prior to the start of each half of the game (by the Official Time Keeper).

8. A siren will signal the start of play (by the Official Time Keeper) but the referees whistle will signal the start of play.
9. A single siren will signal the end of each half but the referees whistle will signal the end of play.
10. Substitutions must take place during breaks of play.
11. There is no off-side rule, however coaches are encouraged to direct players permanently standing in offside positions to move onside.
12. A sin bin rule of 5 minutes will apply to any player constantly infringing the rules. A player who receives a red card will automatically be prohibited from playing in the following game. A player who receives two yellow cards in any two games shall miss the next game.
13. Points are 10 for a win, 2 for a draw and 1 point for each goal scored.
14. The competition will be a round robin with equal pools. On finalisation of the nominations, the Finals format will be determined and communicated to nominated teams 1 week prior to competition commencing. The finals will consist of a semi-final / final format for the A Grade finals. No Extra Time will be played, penalty shootout will be used to determine the winner immediately after full time if scores are level.
15. If teams are level on points after the round robin games, overall for/against goal difference will determine the highest ranked team. If still equal, a count back on the most goals scored for a team, and if still equal, a count back on the least goals scored against will decide the winner. Is still equal, a sudden death penalty shootout will commence.
16. If there is a draw at full time for Division A Finals, then the result will be determined by a sudden death penalty shootout. The player in the goal at the end of full time will be the player in goal for the penalty shoot-out and only players on the field at full time will be able to participate in the shootout.
17. Frenchville Junior Football Club Carnival Officials may make further decisions on the running of the carnival other than what is covered in the above set of rules. Their decision is final.
